- **ONE TIME DONATION (PALM BEACH COUNTY RESIDENTS ONLY)**
- **EXTERIOR USE ONLY**
- **SINGLE FAMILY HOMES ONLY & MUST BE OWNER OCCUPIED**
- **DONATED FOR HOMES OF 3000 MAXIMUM TOTAL SQUARE FOOTAGE (INCLUDES GARAGE, PORCHES, CARPORTS, ETC.)**
- **HOME MUST BE PRESSURE WASHED PRIOR TO PAINTING**
- **PAINT IS NOT SUITABLE FOR USE IN SPRAYERS**
- **DO NOT MIX SWA PAINT WITH OTHER PAINTS**
- **PAINT SETTLES NATURALLY AND WILL NEED TO BE STIRRED WELL PRIOR TO USE**
- **IF APPROVED, PLEASE ALLOW 4-6 WEEKS TO RECEIVE YOUR PAINT DONATION. YOU WILL BE CONTACTED WHEN YOUR PAINT IS AVAILABLE.**
